Year One:

- provide listing of news ('implementation stories'), job and funding opportunities etc. - via monthly email
- act as a conduit for all EIC members to identify partners for EU funded projects or research partnerships in relation to Education/ Implementation for School-Age Children
- hold at least two quarterly online meetings for members on agreed themes
- hold the first annual online event open to all EIC members.

Year Two:

- establish mentorship programme linking established with less experienced implementers
- initiate joint projects and/or apply for joint funding
- continue quarterly online meetings at which common issues and areas of interest will be discussed and potential collective actions agreed
- hold the second annual online event open to all EIC members.
